- Window washing will be scheduled to follow after the re-roofing of all Mountaingate buildings is completed. We have now selected the company to execute this project after reviewing multiple quotes.
- There were no major problems found during most recent carport inspection. A few minor issues needed to be addressed such as proper storage of bikes and removal of non-approved items from carports and/or back patios. Where required, the notices were sent to owners and the issue was addressed and corrected.

#### 3.) <u>LANDSCAPING</u>

• We are working with the landscaping company to trim various trees in the Mountaingate complex to prevent damage to the building envelope and roof.

#### 4.) TREASURER/FINANCE

• Financial statements for May and June 2011 were reviewed by the council members and found to be in order.
